

Catered Camping at Ashburnham Place - 2025

(Effective 1st July 2023)

Catered Camping is available as an option when a group booking is made for a minimum of 250 guests (this includes a minimum of 200 staying in bedroom accommodation).

We can cater for up to 300 (this can be 200-250 staying in bedrooms, 50-100 camping). We can increase this to 350 when our marquee is used as your main meeting space and the Great Hall is used for additional dining space.

The area we use for camping is on South Lawn which is situated alongside Broad Water Lake and can be used with bookings from the end of May to the beginning of September each year.

Camping Facilities – additional charges to consider when camping

We are not a dedicated campsite but offer our grounds to groups with numbers in excess of 250. All camping areas are green field sites with no shower or washroom facilities. Groups wishing to camp will have an additional fixed cost in addition to site fees for the hire of toilet blocks and shower blocks, Site Personnel (set up/cleaning of toilets/rubbish clearance/etc.), Insurance, 10% Management Fee.
